5. **Sealed (HardCopy)** bids must be submitted to the office **Koshi Province Assembly Secretariat** on or before **12:00 PM** on **2083 Ashoj 29 (15th Oct, 2026)**. Bids received after this deadline will be rejected.

Bids must be accompanied by bid security amount as stated in above table either in the form of bank voucher confirming cash deposit in **Koshi Province Assembly Secretariat, Koshi Province Office Code 2020013011, Account No - 2120100202030000, KHA-2-3: DHARAUTI A/C (PRA.LE.NI.KA) at Rastriya Banijya Bank, Biratnagar** or a bid security issued by a commercial bank approved by validity for minimum of 120 days as prescribed format counting from the date of bid opening.
